## Expert System

---

### Irrevocable Burial Trusts Disregard (Change)

---

This change will affect both MED and ADC Budgets.

The new limit for irrevocable burial trusts disregard is \$5,372 effective September 1, 2020 this is for AABD and ADC budgeting.

### MAGI 5% Disregard Rounding (Change)

---

The rounding calculation completed by NFOCUS, to find the 5% disregard amount used in a MAGI budget, has been updated to always round up. Previous amounts that were already rounding up will not change.

### Self-Employment Income from Tax Return (Change)

---

An issue was found with Self-Employment income from a tax returns entered in Expert under the Schedule sections not pulling into HHA budgets. NFOCUS will now correctly pull in the reported Self-Employment income entered under the Schedules for HHA budgets.

## EA Updates

---

### Irrevocable Burial Trusts Disregard (Change)

---

This change will affect both MED and ADC Budgets.

The new limit for irrevocable burial trusts disregard is \$5,372 effective September 1, 2020 this is for AABD and ADC budgeting.

### Child Care Services Authorization (Change)

---

The Authorized Units section in the Child Care Service Authorization correspondence to the provider and individual has been removed.

### Child Care Notice (New)

---

A new notice was created when Child Care cases were reopened within the eligibility period. The new notice lists the month the family fee change occurs instead of the application date.

### Child Care Final Month of Eligibility (Change)

---

When workers were running the final month of the Eligibility Period and the first month of the new Eligibility Period, the new Family Fee was not updating. Now regardless of what month is run first, the first month of the Eligibility Period will list the new Family Fee.

## CFS Updates

---

### Foster Care Home Licensed Slots Available (Change)

---

Due to a longstanding, ongoing issue, the slots available on a licensed foster home can sometimes be calculated incorrectly. A weekly batch job was created to update these incorrect slots.
