**MOTION:** Smidt made the motion, seconded by Jordan, to recommend reinstating an RN license to Carla Bundy on probation for three years with the following terms and conditions: abstain from alcohol; abstain from controlled substances and other prescription drugs unless prescribed by the treating practitioner; verification from treating practitioner of all prescription medications; report all prescription medications taken; submit to random body fluid screens; advise Department of any professional counseling and submit reports; comply with treatment recommendations including recommendations for attendance at support group meetings and sponsor; active practice for 3120 hours; provide notice of disciplinary proceedings to employer and other states where licensed; provide quarterly employer reports; shall not provide nursing services for staffing agencies or in home health care; comply with all reports, notices or other documentation from the Department; promptly respond to Department regarding compliance during probation; obey all state and federal laws, rules and regulations regarding practice of nursing and must report any violations of the above to Department within seven days; pay any costs associated with ensuring compliance, and appear at any meetings of the Board of Nursing when requested. The Board recommends reinstatement

based on current participation in substance abuse treatment, completion of treatment, compliance with treatment recommendations, active involvement in the substance abuse/addiction recovery process, and reported period of sobriety from December26, 2022. The recommendation for probation is based upon diagnosis of a substance use disorder and misdemeanor conviction(s) rationally related to the profession.

**MOTION:** Ruiz made the motion, seconded by Jordan, to recommend reinstating an RN license to Bridget Hegarty on probation for three years with the following terms and conditions: abstain from alcohol; abstain from controlled substances and other prescription drugs unless prescribed by the treating practitioner; verification from treating practitioner of all prescription medications; report all prescription medications taken; submit to random body fluid screens; advise Department of any professional counseling and submit reports; comply with treatment recommendations including recommendations for attendance at support group meetings and sponsor; active practice for 3120 hours; provide notice of disciplinary proceedings to employer and other states where licensed; provide quarterly employer reports; shall not provide nursing services for staffing agencies or in home health care; comply with all reports, notices or other documentation from the Department; promptly respond to Department regarding compliance during probation; obey all state and federal laws, rules and regulations regarding practice of nursing and must report any violations of the above to Department within seven days; pay any costs associated with ensuring compliance, and appear at any meetings of the Board of Nursing when requested. The Board recommends reinstatement based on current participation in substance abuse treatment, compliance with treatment recommendations, active involvement in the substance abuse/addiction recovery process, reported period of sobriety from February 2023, and reported attendance at support groups and maintaining a sponsor. The recommendation for probation is based upon diagnosis of a substance use disorder and misdemeanor conviction(s) rationally related to the profession.

# **EDUCATION COMMITTEE**

## Nursing Continuing Education Advisory Opinion

Members reviewed an Advisory Opinion that had been drafted by the Board's Education Committee regarding continuing education. Reznicek reported that the Advisory Opinion is in response to the elimination of the term "peer-reviewed continuing education" from Nebraska's nursing regulations. Whether or not a particular course would count as "peer-reviewed" seemed to be the source of considerable confusion during renewal periods. Instead, Nebraska RNs and LPNs must now complete twenty hours of continuing education from "an approved provider" during each renewal cycle. The

Advisory Opinion recommends that nurses look for evidence that the provider is approved by the American Nurses Credentialing Center (ANCC), the Joint Accreditation for Interprofessional Continuing Education, or by another state Board of Nursing in order to determine if a CE course will count towards their renewal requirements. Academic courses that a nurse has completed towards an advanced nursing degree will count as approved continuing education. One semester credit hour is equivalent to fifteen contact hours of CE. Nurses can also claim BLS, ACLS, and PALS certifications for renewal contact hours; each type of life support certification can be claimed for the number of hours stated on the certification, or if no hours are listed, each certification can be claimed for four CE hours. The Advisory Opinion also clarifies that RNs and LPNs cannot use Continuing Medical Education to meet their renewal requirements.

**MOTION:** Ruiz moved, seconded by Harrison, that the Board approve the *Nursing Continuing Education* Advisory Opinion.

# **NURING NEWS**

Oertwich reported that she has been notified by Publishing Concepts, Inc (PCI), which publishes *Nebraska Nursing News*, that they are changing their method of delivering newsletters. PCI, which also publishes newsletters for other state Boards of Nursing, will continue to publish four issues a year at no cost to the Board. However, they will cover the cost of mailing the newsletter directly to all licensed nurses within a state for only one issue per year. To deliver the other three issues, Boards can opt either to 1) pay PCI for the cost of mailing each issue directly to each licensed nurse or 2) use PCI's "workplace model" in which packets of the newsletters are mailed in bulk to employers, such as hospitals, clinics, and nursing homes, and the newsletters would then be distributed to individual nurses at the workplace. Board members expressed concerns that if they chose the workplace model, only a small percentage of the newsletters would actually get into the hands of individual nurses. Oertwich noted that PCI also publishes an online version of each newsletter, and that an email with a link to the publication could be sent to licensed nurses when new editions are published.

**MOTION:** Ruiz moved, seconded by Lefler, to approve paying the mailing fees so that hard copies of *Nursing News* can be mailed directly licensed nurses for one more year along with emailing licensed nurses the electronic version of the newsletter, and then after the one year period, transitioning to the model where only one edition each year is mailed in hard-copy format directly to licensees.

## LORNA BREEN FOUNDATION

Oertwich reported that the Nebraska Board of Nursing is one of the first Boards of Nursing to be recognized as a Well Being Champion by the Dr. Lorna Breen Heroes' Foundation. The accolade is awarded to states that do not use overly intrusive mental health questions on their license applications.

## NEW BOARD MEMBER ORIENTATION

Due to the length of closed session, members and staff agreed to conduct the orientation session during a future meeting.

## 2024 LEGISLATIVE SESSION

Oertwich reported that earlier in the year, she had heard that LB1417 was unlikely to get enacted during the current legislative session, but she has heard from others who expect it to pass. The bill includes a proposal to dissolve the APRN Board and put its duties under the Board of Nursing. Oertwich said that language is being drafted to add four more APRN members to the Board of Nursing if LB1417 passes. Hampton noted that LB1417 also includes proposals to merge the Hearing Instrument Specialists Board into the Audiology Board and to merge the Alcohol & Drug Counselors Board into the Mental Health Board.

Oertwich reported that part of the Department's bill for this session, LB1215, includes language that would make enrollment in the Nurys e-Notify system a renewal requirement for all RNs and LPNs. The goal is to use e-Notify to obtain Nebraska's workforce data instead of having nurses fill out workforce surveys when they renew their licenses.

Delahoyde asked about a pending bill that proposes to split the Department of Health and Human Services into three separate departments. Staff did not think the bill had much chance of passing during the current session.

# NCSBN MIDYEAR MEETING

Delahoyde, Motl, and Oertwich, plan to attend the National Council of State Boards of Nursing's Midyear Meeting on March 12-14, 2023. Motl noted that one of the sessions will cover IV hydration issues. Motl was uncertain if the NCSBN project that is formulating uniform education standards for nursing assistants (CNAs) would be addressed at the meeting.

# CENTER FOR NURSING UPDATES

Oertwich reported that the Center for Nursing's marketing plan is expected to launch on March 11<sup>th</sup>. The campaign will be conducted over a three-year period. Oertwich also reported that Stacy Ocander, from the Nebraska Hospital Association, is spearheading efforts to expand clinic sites for nursing students in rural areas of the state. The project includes developing a clinical model that can be shared among sites, finding housing for students, increasing access to simulation labs, and creating paid internships for nursing students.

## COMMUNICATION

Oertwich reported that the Licensure Unit's Nursing Section now has one vacancy after a staff member resigned in January. Staff have also begun processing license applications from nursing students who expect to graduate this spring. Applications have been received form most of the nursing programs in Nebraska.
